- Relay 2023: Oct 20 22 in Houston. Attendees: Carrie plus 3 from our LMSC: Those interested include Beth, Nicki, Brian, Gerry, Tom H, Chris Campbell (current USMS VP moving to MN)
- Current positions open for elections are the following: Vice Chair, Chair, Open at Large, Director at Large
 - Will notify our Masters' members of elections in the next e-bast
 - There is currently an individual running for each position

- Square Lake
 - Nicki recapped the event
 - The general feeling about the event was it was very successful
 - The survey mentioned that people found out about the event via word of mouth. (This is extremely positive to hear)
 - 45 people responded to the survey (This is almost half of the people)
 - Very positive feedback around the event
 - There was an increased in participants this year vs previous years
 - The total number of participants for the event was 95

- The current connection the board had at the U of M has retired from coaching and will impact the cost of LC Masters meets at the U.
 - We will need to consider a location in addition to Richfield for next year
 - The board also suggested finding another contact at the U of M who may be able to help for future meets
 - Tom will continue networking with the U
- Splits requests
 - Due to the fact the meet committee has not been able to connect, they are not briefed in on this
 - Options include: additional timers for each meet (roughly \$7k)
 - Request has been put in to work with coaches and swimmers to explain what a spilt request is and how to request it during the meet
 - Moving forward at the meet, we will review splits request with the coaches, refs, and timers at the start of the meet to help explain it to their swimmers
 - Due to the fact this is a committee conversation, the board has asked this group to discuss and come back to the board by October with a strategy
- USMS Updates
 - Moving forward, there will be a "Code of Conduct" that will be required to be signed upon signup or renewing membership
 - The mission vision and values have been be updated and they will be voted on at the annual meeting
- Website updated
 - There has been no additional work done on it during last few months
 - Board has been requested to determine a budget and scope to assign to a different resource

- Reviewed the financials during the call
