- Spilt Request Recommendations from the Committee:

  - o If you would like a relay split, you will need to request it in advance.
  - In order to get your split, you can request it anytime before or after the event is swum
    - If you request it after the event, you will not get a backup time since it was not planned
  - We are recommending that there be two additional timers at the meets moving forward
  - We will now post the results at the event to remove the overload on the system
  - Two language updates to meet will include the following:
    - There will be a definition of what a split request is
    - As well as noting that if an individual thinks they will break any type of record (local, national, world) they will need to let the meet director know ahead of time so timers can be available
