#### **Motions Made:**

- Motion made to approve the minutes from the previous meetings.
- Motion agreed to proceed with hosting the two national events.

#### **Meeting Notes:**


- **We approved the meeting notes for the last few months.**
- **Annual Meeting 2023 (hybrid): September 8 – 10 in Houston.**
  - Overall, there was positive feedback on the meeting.
  - There is a new group of national board members, including a new president, a new vice president, and a new treasurer.
  - Next year, the meeting will be a virtual event.
  - The new mission and values were approved.

- **One upcoming meeting for the US Masters Relay 2023:**
  - October 20 – 22 in Houston.
  - Attendees: Carrie (funded by USMS) and three from our LMSC, including Beth, Nicki, Gerry, and Chris Campbell (current USMS VP moving to MN). Chris will be funding the majority of his trip.
  - Current positions open for elections are Vice Chair, Chair, Open at Large, and Director at Large. A nomination is only needed for the Director at Large.
  
- **Open Water Swim (OW) buoy:** replacement and loan policy. Currently, the existing buoys are old, and given their condition, the team is asking if the board will approve the purchase of new buoys.
  - There is also a request for people who borrow the buoys to be charged a fee for the use of the old buoys, and new buoys will not be available for other events.
  - The cost for the buoys is approximately \$500 per buoy. The buoy was made by Engineered Textile Products of Mobile, AL (etpinfo.com), 251-476-8001. The buoy is called an R-C Mark.
  - The fee will be a topic for discussion in future meetings.
  
- **Storage Unit:**
  - We would like to change the combination to help ensure the limitations of the use of items in the shed.
  - This will require board members to be present for checking in and out buoys and other equipment for other events.
  
- **Annual Meeting Planning:**
  - Carrie would like the board to be present at the meeting.
  - Carrie needs to get the final checklist of requirements out to the board.
  - A request was presented to the board to ensure the room is available for setup to prevent similar issues as last year.
  - Carrie will create and print pamphlets and work with volunteers for sound and support.
  - The board agreed to provide caps as giveaways.
  
- **USMS 1 Mile:**
  - We have been asked to host two national championship events, both at Square Lake, including the 5K and the 1 mile.
  - The board has made a motion to host these events.
  
- **We reviewed the financials during the call.**
  - September finances were reviewed during the call.
  - More costs will be added during the upcoming week to finalize September's budget and will be reported on in the next meeting.
  - Nick is working on the paperwork for the state.
  - The board has been asked to consider the budget for 2024.
